There are ten (10) open seats on the Filipino Chamber of Commerce of Orange County's ("FACCOC") Board of Directors. Each seat is for a two-year term officially beginning on November 22, 2014 and ending in the last quarter of 2016 when the 2016-2017 Board of Directors is sworn in which is customarily in the last quarter of the year. FACCOC's bylaws currently authorize a total of seventeen (17) directors.

In accordance with FACCOC's bylaws, directors must be (1) a member in good standing (fully paid member as of the election date); (2) of good moral character; and (3) interested in furthering the interests of the organization. FACCOC seeks business owners as well as key employees from established companies (i.e. management and executive level employees) to serve as its directors.

Directors are expected to actively participate on the Board including attending monthly board meetings on a regular basis. Any director who fails to attend three (3) board meetings without reasonable cause or permission may be removed. Directors are further expected to chair various FACCOC events throughout the year and serve on its various committees.

PLEASE NOTE THAT ONLY MEMBERS IN GOOD STANDING [FULLY PAID MEMBERS AS OF THE ELECTION DATE] ARE ELIGIBLE TO NOMINATE INDIVIDUALS AND VOTE FOR THE OPEN DIRECTOR POSITIONS.

Additionally, FACCOC's 2014-2015 officers will be nominated and elected by the 2014-2015 Board of Directors in a closed session immediately following the general election.
